At the August meeting of the FSEA Manasota Chapter, we discussed the ordering of Quickfinders for the current year. Thomson Reuters has changed the formula for pricing the Quickfinders. We have to pay based on the number of books that we order of each type instead of the whole order. Example: If we order 18 of one type and 5 of another type, we get charged a per-unit price for the 18 and another price for the 5. We used to get the over-20 unit price because we ordered more than 20, but not this year. They have also started charging sales tax and a shipping charge of from \$2.00 to \$4.00 per unit based on the quantity purchased in each type.

Therefore, at the business meeting, it was decided that we would get an estimate of which Quickfinders we would need for this year. We would then get an exact price from the supplier. The price will be about the same as last year with a slight increase. We would then decide what price needs to be used. Please use the attached order form to give us an estimate of your quickfinder products. These estimates need to be submitted to me by September 15. After we accumulate all the estimates, we can then tell you what your price would be and you can actually order your products during the latter part of September and early October along with your payment. You can then pick up your products at the meetings in December or January. If you cannot pick up your quickfinder products, please have someone get them for you. Otherwise, they will be left at Mary Jean Wenzel's office for your pick up at your earliest convenience.
